Membership Application

Hospitality & Retail Membership applies to businesses that sell, serve or promote Hampshire-grown produce that are based in Hampshire or in close proximity to the county boundary.

Criteria detail:

Retail:

(relating to farm shops, delicatessens, butchers, fishmongers, off-licenses, box schemes, hamper providers, e-commerce sites, village stores, corner shops and attractions with a shop)

- Retail outlets must sell products or raw ingredients from at least 5 Hampshire producers (see Producer Membership criteria for businesses that qualify as producers).
- **Fishmongers** must offer at least 5 species landed off the coast of Hampshire or within 10 miles of the county boundary.
- **Butchers** - at least 4 out of 8 of the following must be of Hampshire origin or from within 10 miles of the Hampshire county boundary:
 - lamb ■ beef ■ pork ■ chicken ■ other poultry ■ game birds ■ venison ■ rabbit
- The business itself must be based in Hampshire or within 10 miles of the Hampshire county boundary.

Hospitality:

(relating to pubs, cafes, restaurants, hotels, B&Bs, guesthouses, caterers and attractions with a cafe)

- At least 2 products from each of the following categories must be on the menu at all times from Hampshire producers (see Producer Membership criteria for businesses that qualify as Hampshire producers):
 - meat, fish & game ■ fruit & vegetables ■ eggs & dairy products ■ drinks and condiments
- The business itself must be based in Hampshire or within 10 miles of the Hampshire county boundary.
